Program Overview & Admissions	
<ul style="list-style-type: none"> <li>Any student with any major may apply to a combined degree program; however, some programs have specific prerequisite requirements, please discuss with a GWSB advisor.</li> <li>Students who are admitted to the BSF program and have completed 75 credit hours with a cumulative GPA of 3.25 or better may apply for admission to the BSF/MSF Combined Degree Program. In evaluating applications to this degree, special attention will be given to grades in Accounting and Finance courses.</li> <li>Upon acceptance, students are eligible to register in MSF graduate courses. A max of 12 credit hours of graduate level courses may count towards the BSF degree. The BSF degree is awarded after the successful completion of the undergraduate requirements. The MSF degree is awarded separately upon the successful completion of the graduate requirements.</li> </ul>	
<p><b>Graduate courses may potentially be used toward the following undergraduate requirements:</b> BSF students could apply the graduate courses listed above towards the "Additional Finance Courses" requirement. BBA/BAccy students could apply the graduate courses listed towards their Elective Requirements. <b><i>Students must meet with a GWSB advisor in the Undergraduate Advising Center to determine how to best utilize the graduate courses in the undergraduate degree.</i></b></p>

The Master of Science in Finance (MSF) combined degree is designed to provide students with more depth and breadth in the Finance domain. The MS in Finance Program produces leaders in the field of finance. The program focuses on risk management, financial engineering, banking, corporate finance, and portfolio analysis and management. It has been designed to combine quantitative and computer skills with financial theory and applications. The MSF program qualifies as a STEM program.

### Career Options with the BSF

MSF graduates find employment at the most prestigious financial institutions including Goldman Sachs, Morgan Stanley, Merrill Lynch and Wells Fargo, among others. - A second major outside of the Business School is required and may include more or less courses than outlined. Please work with your advisors for planning.
- Electives may include courses in/out of the Business School, may be used to pursue a minor, to study abroad, explore different disciplines, but may not include LSPA (Lifestyle, Sport, and Physical Activity) courses.
- Certain courses on this academic plan may be moved from one semester to another; work closely with your academic advisor if you choose to do so.
