The first year of requirements is the same for all GWSB students regardless of the degree pursued: Bachelor of Accountancy (BAccy), Bachelor of Business Administration (BBA), or Bachelor of Science in Finance* (BS). In addition, the requirements for the BBA and BAccy can be aligned for the second year as well. This gives our students time to explore and research the different degree options offered in GWSB.

A Minor/Second Major:

GWSB students who pursue the BAccy degree are encouraged to minor outside the School of Business, although this is not a mandatory requirement. Minors range from 15 credits to 21 credits; most are 18 credits. A second major could be approximately 30 credits. Students can apply their electives to a minor or second major.

Sitting for the CPA Exam:

The BAccy degree program helps to prepare students to sit for the CPA exam; however, requirements beyond the exam (ie - number of credit hours completed) vary by state, so students should obtain further information from the state licensure board(s) of their choice.

Studying Abroad:

The electives in the BAccy degree provide the opportunity to study abroad and still complete all of the accountancy major courses in four years. Due to the specific sequencing of the BAccy degree, please work with a GWSB advisor to plan your academic schedule with study abroad in mind.
